## Kiwanis Club of Lapeer 2022 Rubber Duck Dash

## **Official Rules & Regulations**

- The 2022 Rubber Duck Dash is presented for the benefit of the Kiwanis Club of Lapeer, a non-profit organization under Section 501 (c)
  (4) of the Internal Code (the "Presenter"). The Michigan gaming license number is R65240.
- 2. The Rubber Duck Dash shall be open to legal residents of the United States who are at least 18 years of age (the "Entrant"). Prize winners must be individuals at least 18 years or older, or a parent or guardian must accept the prize. Winners must show proper identification when claiming prizes. The prizes may be not substituted or exchanged.
- 3. The Kiwanis Club of Lapeer requests a \$5 donation per Duck Adoption to benefit the charitable work of the Kiwanis Club of Lapeer.
- 4. Duck Adoptions may be made through 1:00pm EST day of the event.
- 5. Chances of winning depend on the total number of qualified entries. A minimum of 500 ducks will be entered in to the race. If 500 or fewer ducks are sold, the race will convert into a strict 50/50 drawing.
- 6. Refunds will not be granted for any reason.
- 7. The entry information on the stub of each Duck Adoption Ticket must be completely filled out and delivered to the Presenter or an authorized representative of the Presenter.
- 8. Privacy Notice: When entering into this race, you may provide personal information, including, but not necessarily limited to your name and email address. We will only use such personal information to enter you in the Race and contact you if you win. Under no circumstances will personal information be shared with any third party not related to the conducting of the Race. By entering the Race, you have agreed to permit the Presenter to keep and use your information to keep you informed about future events and /or information related to the Kiwanis Club of Lapeer.
- Ducks will be launched into Farmers Creek at Cramton Park in Lapeer, Michigan at approximately 2:00pm EST on Saturday, September 17, 2022. The ducks will be dropped into the river all at the same time. The Kiwanis Club of Lapeer has established the course for the race. The waterway will be relatively free of obstruction.
- 10. A number will be written with waterproof ink on each duck relating to the number on the official Duck Adoption Ticket. The person whose name appears on the duck adoption ticket that matches a winning duck will be awarded the corresponding prize in order of finish.
- 11. All ducks entered into the Rubber Duck Dash will be provided by the Kiwanis Club of Lapeer and will remain the property of the Kiwanis Club of Lapeer . The ducks will be unbreakable, unsinkable, and of the same size and weight. Once the ducks are launched into the river, they are on their own. No attempt to free or interfere with any ducks is permitted.
- 12. There will be a finish line with a chute to trap the ducks, one at a time, in the order of finish.
- 13. The event is subject to all federal, state and local laws and regulations and is void where prohibited by law.
- 14. By participating, the Entrants release the Kiwanis Club of Lapeer and its directors, managers, staff, volunteers and other related event partners and sponsors from liability with respect to all prizes.
- 15. In case of inclement weather or unforeseen circumstances that prevent the launch of the ducks, a winner shall be determined by a traditional raffle drawing on the same day at 3:00 pm.
- 16. By entering, winners consent to the promotional use of their names and likenesses without additional compensation.
- 17. Entrants need not be present to win. If necessary, winners will be notified by email, telephone or mail within 5 days of the race. If prize is not claimed within 60 days following the race, the Presenter will select an alternate winner through a random drawing of entry numbers.
- 18. A list of prize winners will be posted online at www.kiwanislapeer.org.
- 19. A copy of these rules and regulations will be available online at <u>www.kiwanislapeer.org</u> and will be posted at the event. All decisions and interpretations of rules, regulations and final determination of winners shall be made by Presenter.
- 20. Duck Adoption purchases may not be fully deductible as a charitable contribution. Please check with your tax advisor. The IRS has taken the position that amounts paid for chances in raffles, lotteries or similar drawing for valuable prizes are not gift, and consequently do not qualify as deductible charitable donations.
